The project generally includes the procurement and installation of aluminum curtain wall and storefront systems.

Bidders are advised that this contract will require the contractor and subcontractors to pay prevailing wage rates as a minimum in accordance with the current State Wage Rate Schedules. Bidders shall be advised that this contract requires participation by certified disadvantaged businesses as follows: **MWBE Goal: 30%, SDVOB Goal: 6%**.
